MOHLTC/LHIN Joint Capital Review Framework

Ministry-LHIN Performance Agreement

As part of the Ministry-LHIN Performance Agreement (MLPA), the MOHLTC/LHIN CWG continues to implement two (2) provisions contained in this agreement: Own Funds Capital Projects; Post Construction Operating Plan (PCOP). To this end two subgroups of the CWG have been established in order that these provisions are implemented.

Own Funds Capital Projects Subgroup

The MOHLTC/LHIN Performance Agreement (MLPA) defines Own Funds Capital Projects as follows:

Own Funds capital projects are those capital projects funded by a public hospital without capital funding from the Government of Ontario, including the MOHLTC and the LHIN.

Based on the MLPA, the CWG will develop mechanisms to devolve the review and approval of hospital Own Funds projects to LHINs, as appropriate, and subject to eligibility criteria established by MOHLTC.

The Own Funds Subgroup, reporting to the CWG, will accomplish the following:

 Identify issues and recommendations for their resolution related to devolving Own Funds Capital Projects to the LHIN;

- Develop recommended eligibility criteria to be established by the MOHLTC for these projects;
- Develop an "Own Funds Capital Projects Toolkit" as a supplement to the MOHLTC/LHIN Joint Review Framework for Early Capital Planning: *Toolkit* that describes the relationship, and roles and responsibilities for MOHLTC and LHIN with regards to Own Funds Capital Projects;
- Develop a communications plan for MOHLTC, LHIN and HSPs.

Post Construction Operation Plan Subgroup

The MOHLTC/LHIN Performance Agreement (MLPA) defines PCOP as follows:

"PCOP funding" means post-construction operating plan funding provided to a public hospital in the local health system for service expansion and other costs occurring in conjunction with the completion of an approved capital project.

The MOHLTC will determine the amount of the Dedicated Funding Envelope for PCOP funding for a public hospital in the local health system for each fiscal year, including any conditions of such funding;

The LHIN will use the Dedicated Funding Envelope for PCOP to provide funding to public hospitals in accordance with the conditions of such funding and incorporate any conditions of the funding into service accountability agreements with public hospitals.

The PCOP Subgroup, reporting to the CWG, will accomplish the following:

- Consistent with each of the Capital Planning Stages, define the roles and responsibilities of each of the LHIN and ministry with respect to the development, execution, and reconciliation of a PCOP;
- Consider and recommend approaches to address changes to a previously agreed to PCOP as a result of changing service needs that may occur in the planning, design, and construction phases of a project;
- Review and recommend revisions to the process and requirements in the *Toolkit* to ensure alignment with PCOP hospital submission requirements, including changes to current processes, as required;
- Develop a supplement to the above-referenced Toolkit that describes the relationship, and roles and responsibilities of the ministry and LHINs with regards to the PCOP process;
- Develop a communications plan for MOHLTC, LHINs and HSPs.

CT Designation Protocol

On July 29, 2011, a revised version of the CT Protocol for the submission, review and approval, of CT designation requests was sent to all LHINs from the LHIN Liaison Branch. The revised Protocol includes a Business Case template that is to be completed by all hospitals submitting a request for CT Scanner designation. The standardized Business Case template is required to better ensure hospitals have met the capital criteria associated with approval of a CT Scanner.

Orientation Sessions
