The Opportunity

As a member of the Corporate Services team, the Business Intelligence Developer supports the Application Support Supervisor in developing reports, organizing the report depot and managing the database. The Business Intelligence Developer coordinates assigned system projects, is responsible for information management, extracting source data, and maintaining the data warehouse to ensure accurate reporting and data quality. Areas of responsibility include data management, data tools and reporting. The Business Intelligence Developer participates in and demonstrates an understanding of quality, risk and client safety principles and practices. They also follow all safe practices and procedures to support a safe client and working environment.

What Can I Expect to Do?

- Supports the organization in the development and delivery of standard reports and ad hoc queries, and in organizing the report depot
- Manages information in terms of analytical/reporting tools, data architecture and storage, data cleansing and integration
- Extracts data from feeder systems (as applicable), for example: incident reporting, finance, workload, MIS, PCS
- Assesses data quality in terms of completeness, accuracy, and timeliness; makes recommendations for improvement
- Assists in the collection and analysis of information and data related to performance indicators and benchmarks for all areas of the organization
- Coordinates all application development and maintenance projects, including managing vendor relations
- Develops and implements information products: Report, Pivot Table, On Line Analytical Process (OLAP) Cubes, Ad-Hoc Data Extracts, Complex Structured Query Language (SQL) Statements
- Participates in the planning and implementation of data warehouse
- Selects and implements analytic reporting tools (Crystal Reports, etc.) based on business requirements
- Supports the collection and evaluation of business requirements
- In consultation with Business Intelligence Manager, implements a process to identify and document problems with data quality and makes recommendations to system owners for improvement
- Manages vendor relationships during application development and for maintenance projects
- Support role of end user with front line report tools
- Works with data analyst to develop a shared understanding of report requests
- Coordinates application development and maintenance projects
- Participates in several projects and initiatives simultaneously, dealing with multiple stakeholders, processes, deadlines and requirements
- · Researches and tests new techniques to improve efficiencies of information products
